The advice totals section shows a summary for the paystub. Advice totals show your current and year-to-date totals. The Year-to-Date column for Taxable Pay will only show the taxable pay since the transition to Munis. It will not show totals from the first half of 2021 when payroll was being processed in IFAS. Taxable Pay will be correct on your end of year W2.

Explanation on Holdback for Expanded Pay Employees

A percentage of your gross per period pay is being withheld in the background to fund your summer checks when you are not working. This amount is figured into the calculation of your take home pay. This percentage is based on your total scheduled days. Those employees who start working later in the scheduled work year will have percentages based on the remaining work days in their school year.
